

IMUNE / Provider of Education Agreement Mutual Accreditation



This is an agreement between _____ the International Medical University of Natural Education (“**IMUNE**”) of BVI, represented by the Chairman of the Board or the Vice Chancellor and _____ (“**The Supplier of Education**”), represented by _____ (Collectively “**The Parties**”).

General Clauses

1. The International Medical University of Natural Education (**IMUNE**) based in the British Virgin Islands, having operated for over 10 years, exists to offer quality education of all forms of Natural Medicine and to protect the field of Natural Medicine. **IMUNE** operates a licensing authorising agency that works within it. This offers a wide range of International Licenses in the medical arts. By operating in International Waters **IMUNE** is able to operate for the educational benefit and protection of Natural Medicine worldwide.
2. **IMUNE** provides reference syllabuses and also operates as a provider of education by offering and/or facilitating courses. Additionally **IMUNE**, via the ILAA (International License Authorisation Agency), issues International License Qualifications.
3. **IMUNE** seeks to affiliations and mutual accreditation with other educational agencies to help propagate the field of natural medicine.
4. The intention is mutual co-operation to support the development of education and educational standards in natural medicine, both through **IMUNE** and by collaboration with other educational organizations.
5. This contract is designed to officially document Mutual Accreditation
6. By this mutual accreditation each party recognises that the other operates in the development of education for Natural Medicine both traditionally and technology based.
7. By this mutual accreditation each party recognises that the other has modules within its programs that:
 - a. Offer education in Natural and/or Quantum Medicine.
 - b. Meets the standards and type of education in Natural and Quantum medicine that is the goal of **IMUNE**
8. This agreement shall be in force for a period of two (2) years after its initiation and can be renewed on the agreement of both parties.
9. Both Parties agree:
 - a. To mutually support in activities that support Natural medicine including the

- provision of information, education, seminars, conferences
 - b. Not to disclose under any circumstance to any unauthorized personnel or organization, confidential information and trade secrets concerning products, technologies and related business arrangements of the parties.
 - c. To mutually share in a timely appropriate manner, “Market Intelligence” or “Know How” which include, but are not limited to surveys, complaints, appraisals and/or rumours.
 - d. To act firmly, quickly and positively to dispel any negative rumours and/or bad press towards IMUNE or the POE.
10. This mutual accreditation does not constitute in any form a legal bond between the Provider of Education and IMUNE and in particular neither party will be legally responsible for the actions of the other.
11. The mutual accreditation between a POE and IMUNE clearly defines that the POE and IMUNE are legally, politically and financially independent. In particular the POE even if he provides the education to IMUNE Qualification standards and makes available information concerning IMUNE and/or IMUNE activities or qualifications is not legally responsible for any of IMUNE and IMUNE’s licensees actions in any way, shape or form. The reverse is also agreed.
12. Each party agrees to adhere to **IMUNE** standards, ethical principals and basic curriculum style and curriculum content. It is fundamental that core curriculum content must be maintained between parties whilst allowing extension of content to include additional relevant material.
13. Both “Parties” agree to refer to each other inquiries from prospective clients whose requirements are best served by the other party. This applies to business/education inquiries posted either on or off the Internet and/or any other media support.
14. During the term of this agreement each party may include in information this affiliation and use authorised logos that display this association, specifically the POE may use the IMUNE Affiliated Logo (displayed below)
15. In case of any irreconcilable dispute between the parties, this agreement shall be interpreted, tried and enforced according to the jurisdiction of International Law.
16. It is implicit in this agreement that the POE and IMUNE will provide access to information about the other and its offerings. This shall include access details for each organization on the others website.

Specific Clauses

1. It is recognised that there are two types of Providers of Education (POE)
 - a. POE’s that offer education only with qualification documents issued by an independent authority via an independent process. (e.g. external examination and

- b. POE's that offer both education and an associated qualification.
- 2. Where the POE does not offer a qualification:
Where the POE operates courses only they will offer full recognition for verified IMUNE graduates or license holders for equivalent courses. This is effectively cross credits. Such course equivalence will be mutually agreed as an addendum to this agreement. (e.g. if IMUNE has a course module that provides credits (towards for example an Expert License) and the POE has an equivalent course (for example towards a Quantum Naturopathic Qualification) then the IMUNE course will be accepted as equivalent (and vice-versa)- the POE/IMUNE may make an administration charge).
- 3. Where the POE does offer a qualification:
The Provider of Education (POE) agrees to fully accredit IMUNE qualifications including international licenses where the POI operates a qualification process within their operation. Such qualification equivalence will be agreed on a case by case basis.
- 4. The Courses and Qualifications that are agreed at this time to be mutually accredited are as listed below.
- 5. Additional mutual accreditations will be detailed on a supplementary form as below
